Pacifico Share Purchase Plan Closure and Results

Pacifico Minerals Ltd (ASX:PMY) ("**Pacifico**" or "**the Company**") wishes to announce that the Share Purchase Plan ("**SPP**") as announced on 18 September 2020 closed at 5pm on Tuesday 6 October 2020. The Company received applications for 13,333,322 shares under the SPP raising \$240,000.

The funds raised under the SPP and the previously announced placement, will be applied towards:

- (a) Completion of the Definitive Feasibility Study for the Sorby Hills Lead-Silver-Zinc Project;
- (b) High-impact drilling program across multiple near-mine and quality exploration targets;
- (c) finalisation of permitting and approvals required to begin construction;
- (d) finalisation of offtake and financing arrangements; and
- (e) general working capital requirements and offer costs.

The SPP was offered to all existing eligible Shareholders to give them the opportunity to subscribe for new shares at A\$0.018 per share (being the same price as the Placement Shares) up to a maximum of 1,666,667 shares (maximum of A\$30,000) per investor.

The Board wishes to thank all shareholders who participated in the SPP for their continued support of the Company.

The Company will not be issuing any of the Shortfall from the SPP. Shares issued under the SPP have been allotted today.
