CHAIRMAN'S ADDRESS

Dear Fellow Shareholder.

I am delighted to present Pacifico's 2016 Annual Report.

It's been another difficult year but a year with some pleasing progress, in spite of the challenging market conditions which confronted the junior resource sector.

Progress on the Company's projects over the past 12 months has been modest due to financial constraints. However, focussed exploration including drilling programs at both of our key projects in Australia and Colombia has continued to provide a significantly better geological understanding.

During the year the Company reached its expenditure commitment on our Borroloola West project and in doing so earnt the right to 51% of the project. Pacifico then went on to elect to form a joint venture with leading Australian copper producer Sandfire Resources, with Pacifico as the operator. As a result of both company's continuing positive view on the prospectivity of the project, Sandfire has agreed to contribute its 49% share of all exploration costs towards the 2016 program.

The recent gold price increase has provided additional interest in the Company's highly prospective Berrio gold project in Colombia. With renewed market interest and a much improved gold price, we are confident that significant progress can be made with the Berrio project in Colombia over the next 12 months.

Pacifico continues to explore with a clear objective of finding a world class mineral deposit but not without acknowledging the difficult equity market conditions and making sensible decisions when constrained by limited financial and personnel resources.

I would like to acknowledge the work and dedication of our first class team who continue to progress the Group's assets with a highly disciplined approach.

To you our Shareholders, the Board is grateful for your continued support for Pacifico. To our committed and exceptional team, your Board commend you for the dedicated services. To my fellow Board members your support has been invaluable during this difficult year.

Market conditions remain challenging, however, I sense we may well have seen the bottom of this downturn and rewards are now available to those juniors with the right portfolio, the right strategy and a clear path of how to return value to Shareholders.

We look forward to an exciting year with new opportunities in 2016 with the excellent gold price hopefully continuing and a renewed interest in Junior Exploration

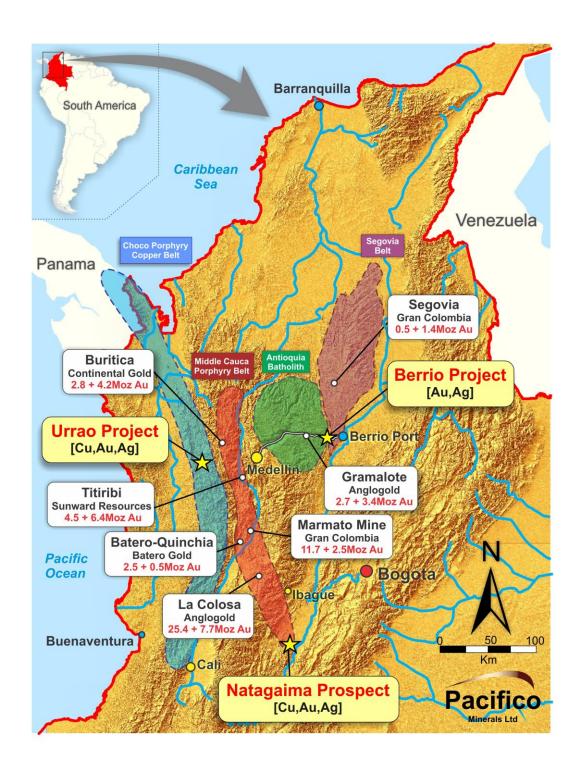


Figure 1: Pacifico project locations map



BERRIO PROJECT, COLOMBIA - GOLD (PACIFICO 100%)

The Berrio Gold Project is situated in the southern part of the prolific Segovia Gold Belt and is characterised by a number of artisanal mining operations. The project is 35km from the Magdalena River which is navigable to the Caribbean Sea and has excellent infrastructure in place including hydro power, water supply, sealed roads and telecommunications coverage.

The local geology has been intruded and is bounded by a fertile granodiorite – a classical and known geological setting for gold deposits.

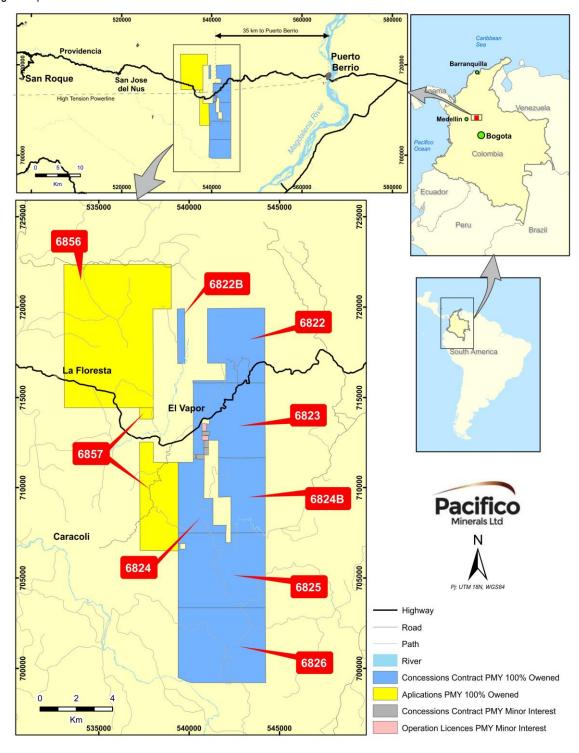


Figure 2: Berrio project location map and associated infrastructure

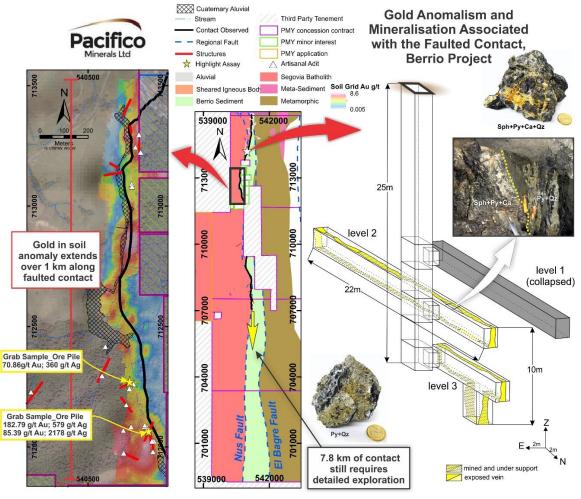


Figure 3: Compilation of information relating to the faulted contact at the Berrio project

A faulted contact, separating the Berrio Sediments from the Segovia Batholith, extends for 14 km within the Berrio Project, less than 25% (approximately 3 km) of which has been explored in any detail. Pacifico interprets this contact to be a critical control for high grade gold mineralization exploited by artisanal miners in the area. Artisanal miners typically exploit high-grade but mostly discontinuous lodes in the Berrio Sediments or narrow quartz veins in the Segovia Batholith, both of which are abundant close to the contact. Examples of artisanal miners operating at the contact are limited, Pacifico believe, this is in part due to suppressed topography at the contact which often hides the contact below the water table and beyond the reach of most artisanal miners. During 2015 Pacifico started exploring the contact with soil geochemistry, starting at the north and working south, and defined several gold in soil anomalies one of which extends unbroken from over 1 km (see figure 3) (see ASX announcement 25 June 2015).

During July Pacifico announced highly encouraging results from a channel sampling program at the Berrio Gold Project. Channel sampling of an artisinal mine, which exploits mineralization at the contact, identified significant precious and base metal mineralization. 11 channel samples from artisanal workings were taken at various intervals covering 22m of contact strike. Of importance is the fact that these artisanal workings only occupy a small fraction of the 14km mineralised structure mapped at the Berrio Gold Project. Previous exploration by Pacifico along with these channel sampling results indicate that mineralisation continues along the contact 20m below surface and remains open at depth as well as to the north and south. High-grade gold and silver mineralisation hosted at the contact between the Berrio Sediment Package and Segovia Batholith included:

- 50cm @ 42.49 g/t Au, 77.5 g/t Ag and 0.24% Cu (channel sample 43567)
- 50cm @ 33.24 g/t Au, 146 g/t Ag, 0.34% Cu and 0.84% Zn (43571)
- 80cm @ 31.41 g/t Au, 106 g/t Ag and 0.23% Cu (composite channel sample 43566 and 43570)
- 50cm @ 8.19 g/t Au, 59.5 g/t Ag, 0.5% Cu and 23.48% Zn (43569)

Channel sampling was undertaken across two levels and was restricted to faces and pillars left by miners to act as support in stopes. Previous field mapping, selective grab and soil sampling undertaken by Pacifico identified gold anomalisms associated with the contact between the Berrio Sediments and Segovia Batholith. See Table 1 for all 11 channel sample results. These channel sample results strongly support Pacifico's exploration strategy along the faulted contact between the Berrio Sediments and Segovia Batholith.

During November 2015 Pacifico provided a further update on exploration activities from the Berrio Gold Project including further channel and grab sampling from within artisanal mines close to the faulted contact as well as the conclusion of the soil sampling program. Highlights from the channel sampling and grab sampling included:

- Underground channel sampling sampling identifies further high-grade gold mineralization close to the faulted contact, returning multiple ounce gold and silver assays including:
 - 0.35 m @ 182.79 g/t Au and 579 g/t Ag (Sample MO6256)
 - o 0.10 m @ 70.86 g.t Au and 360 g/t Ag (Sample 43876)
 - 1.30 m @ 16.54 g/t Au and 1296 g/t Ag (Sample 43861)
 - 1.70 m @ 4.28 g/t Au and 21.58 g/t Ag (Composite) (Samples 43876, 43877 and 43878)
- Selective grab sampling returns further high-grade
 - o 20.99 g/t Au and 203 g/t Ag (Sample 43868)
 - 10.99 g/t Au and 15.6 g/t Ag (Sample 43866)
 - o 15.73 g/t Au and 8.5 g/t Ag (Sample 43867)

Channel Sampling

Expanding on the channel sampling program started earlier in the year (see ASX announcement 9 July 2015) a further eleven artisanal mines were evaluated by Pacifico, of which, five were sampled – all of which are located in the northern most 3 km of the contact within Pacifico's tenements. 26 channel samples were generated (see table 2) at or close to the faulted and mineralized contact. Mineralised structures in the Berrio Sediments are typically wider than those in the Segovia Batholith. Base metal content of veins is typically higher in the Berrio Sediments compared with veins in the Segovia Batholith.

Soil Sampling

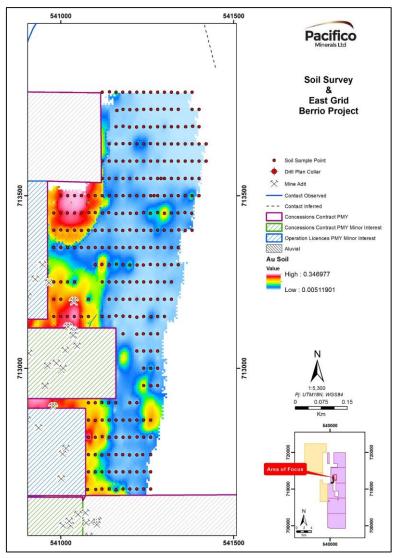


Figure 4: Soil sampling eastern grid

The soil survey, extending across the contact, concluded with the completion of the East Grid (see figure 4), earlier surveys were reported previously (see ASX announcement 25 June 2015).

The East Grid extended 1 km north-south over of the Berrio sediments east of the faulted contact. The western portion of the soil survey recognized anomalism coincident with artisanal mines. The soil survey suggests that mineralization hosted in the Berrio Sediments diminishes with increasing distance from the faulted contact.

In January 2016 Pacifico announced the commencement of a diamond drilling program at the Berrio gold Project, the planned (up to 2000m) program targeted three zones of high-interest.

Drill Targeting

Drilling focusing on the contact as it is thought to be the major structure influencing mineralization in the El Vapor/Berrio area. A combination of exploration data, collected over two years, highlights three zones considered of highest interest, these three zones will be targeted in the up-coming drill program:

- Down dip and along strike extensions of HIGH-GRADE mineralization sampled in artisanal mines
- High-interest targets defined by a combination of; field mapping of the contact; gold in soil anomalies; and coincident IP chargeability highs and resistivity lows
- A flexure in the contact with a coincident gold in soil anomaly which is considered by Pacifico as a potential structural trap which might develop high grade

Summary

Drilling targeted three zones along the contact between the Segovia Batholith and Berrio Sediments. Eleven drill holes were completed for a total of 986.20m.

Drilling demonstrates the contact is either faulted or intrusive, varying along strike. When faulted the contact acts as a conduit for ascending fluids manifesting as alteration and or mineralisation. Where the contact is intrusive mineralisation is not observed. Mineralisation developed at the faulted contact varies, in terms of thickness and grade, along strike and down-dip. Mineralisation is thought to develop as plunging ore-shoots. To date, Pacifico have investigated only a small portion of its' licence area – over 10 km of the contact and 700 hectares of the Berrio Sediments have yet to be explored in significant detail.

Northern Zone

In the Northern Zone the contact between the Berrio Sediments and Segovia Batholith is sheared. Drilling targeted extensions of mineralisation at the contact observed and sampled in various artisanal mines. Six drill holes (BE16-026 to BE16-030 and BE16-036) were completed (555.50 m) in the Northern Zone, in each instance the contact was crossed, demonstrating a subvertical (80-85 W) dip. Alteration and mineralisation is developed to varying degrees at the contact in each drill hole. BE16-026, BE16-029 and BE16-036 generated the highest grade intersects (Table 5) - these drill holes targeted mineralisation under artisanal mines. BE16-027 and BE16-028 targeted along strike extensions of mineralisation in artisanal miners and hosted lesser developed mineralisation. BE16-026 - Berrio sediments are sheared from the contact (79.24 m) to a downhole depth of 81.50 m. Ground clasts of quartz vein with up to 20% coarse grained disseminations of pyrite are recorded in this shear zone. BE16-029 – Berrio sediments are sheared from the contact (41.90 m) to a downhole depth of 46.82 m. Clasts of quartz vein with coarse grained disseminations of pyrite are recorded in this shear zone. BE16-036 - Berrio sediments are sheared from the contact (55.15 m) to a downhole depth of 61.00 m. A 19 cm* quartz vein with 5% pyrite is recorded in the shear zone as well as clasts of ground quartz vein with pyrite.

*All intersections are reported as downhole intervals. True widths are not known.

Central Zone

The contact in the Central Zone was targeted based on gold in soil anomalies and IP chargeability and resistivity anomalies. Four drill holes (BE16-031 to BE16-034) totalling 359.20 m were completed from two platforms demonstrating that the contact assumes an approximately 45 E dip – this is a significant change in orientation when compared to the Northern Zone. BE16-031 and BE16-032 were drilled from the same platform and targeted the downward projection of gold in soil anomalies recorded at the contact as well as aiming to undercut artisanal mine workings. BE16-031 crossed the contact at 35.82 m and BE16-032 crossed the contact at 37.20 m indicating the contact dips approximately 46 E. The contact is not mineralised. Mineralisation is confined to narrow (<3 cm) quartz pyrite (+/- galena, sphalerite) veins in zones of healed breccia within the Segovia Batholith, these zones are typically sericite altered. BE16-033 and BE16-034 were drilled from the same platform and targeted the downward projection of gold in soil anomalies recorded at the contact as well as IP chargeability and resistivity anomalies. BE16-033 crossed the contact at 42.15 m and BE16-034 crossed the contact at 46.70 m indicating the contact dips approximately 42 E. The contact is not mineralised.

Flexure Zone

A flexure in the contact with coincident gold in soil and IP chargeability anomalies was identified as a potential structural trap. BE16-035 is the only drill hole in the Flexure Zone and measures 71.50 m. BE16-035 crossed the contact at 27.90 m. The contact is not mineralised.

Discussion of Results

Recent exploration demonstrates that mineralisation and the orientation of the contact between the Segovia Batholith and Berrio Sediments varies significantly along strike. Mineralisation in the Northern Zone is associated with sub-vertical shearing and forms discontinuous ore-shoots which might have greater continuation with depth than along strike. The contact in the Central and Flexure Zones assumes a moderately easterly dip, is not strongly sheared and does not host significant mineralisation. Gold in soil anomalism, used to aid drill targeting in the Central and Flexure Zones, is probably sourced from narrow quartz veins in the Segovia Batholith. Several such veins were intersected by BE16-031, on three occasions these narrow (<3cm) veins carried grade in excess of 1 g/t over an intervals of 50 cm or greater. Strong IP chargeability (high) and resistivity (low) anomalies, recorded at the contact, in areas with gold in soil anomalism, in the Central Zone, are not associated with significant mineralisation. This is in stark contrast to previous drilling in the Berrio Sediments which demonstrated a strong relationship between IP anomalies and zones of significant mineralisation.

During the fourth quarter regional mapping continued to identify additional areas of interest as well as areas of low interest which can ultimately be excluded from the tenement package to reduce holding costs.

Further Exploration

The Berrio Project is situated within the Segovia Gold Belt, the most prolific gold belt in Colombia, from which millions of ounces of gold has been produced over 150+ years. The Segovia Gold Belt continues as a focus for exploration and mine development within Colombia. In excess of 10 km of the contact and 700 hectares of Berrio Sediments have yet to be explored in significant detail, see figure 1. Subsequent exploration, including, prospecting, mapping and sampling will be undertaken in these under-explored areas known to host artisanal mines. Efforts are ongoing to identify and gain access to abandoned artisanal mines which have not yet been channel sampled. Pacifico will return to active mines, as they advance, to collect further channel samples.



NATAGAIMA PROJECT, COLOMBIA - COPPER/SILVER (PACIFICO LODGED APPLICATION FOR 100%)

The Natagaima licence application is situated in the department of Tolima, approximately 5km west of the navigable Magdalena River which drains into the Caribbean Sea. No further exploration work was conducted during the financial year.

- Colombia operates a "first right" system with its licence application process and Pacifico was the first, of many interested parties, to register its application over Natagaima upon the area becoming available
- Located within the Middle Cauca Porphyry Belt
- Near existing electrical lines, roads, rail line and a major river

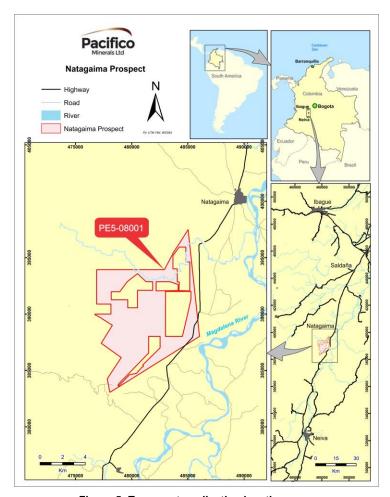


Figure 5: Tenement application location map



- Mapping, outcrop sampling and project wide stream sediment sampling has generated very encouraging geochemical anomalies.
- Initial work indicates prospectivity for epithermal and porphyry style mineralisation
- Two mineralised and intersecting trends identified are prospective for precious and base metals
- Selective grab sampling1 generated the following grades:
 8.42g/t Au, 6.2% Cu, 2.3g/t Au, 1.35% Cu, 9.3% Pb and 1.12% Zn, 2.1% Cu and 1,395g/t Ag

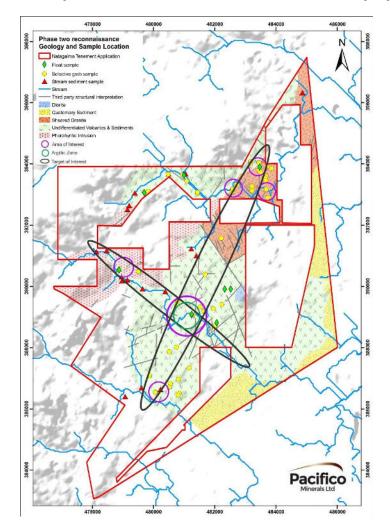


Figure 6: Tenement location map highlighting mineralised trends

Several programs for follow-up exploration are under consideration including:
Targeted detailed mapping, Channel sampling of gold bearing quartz veins, Mag and IP survey and Trenching

Follow up exploration will continue only once the Natagaima tenement application is granted to Pacifico. Follow up exploration will include detailed mapping and trenching of areas of interest.



URRAO PROJECT, COLOMBIA - COPPER/GOLD/SILVER (PACIFICO 100%)

The Urrao Project is part of the Choco porphyry copper belt and is located 35km north west of Tarso in the municipality of Urrao and Salgar. The project consists of one granted title covering a total area of approximately 902 hectares. No significant exploration was undertaken during the year. Tenement IHL16271 which formed part of the Urrao project was relinquished. A new exploration tenement application 100% owned by Pacifico has since been placed over the same area.

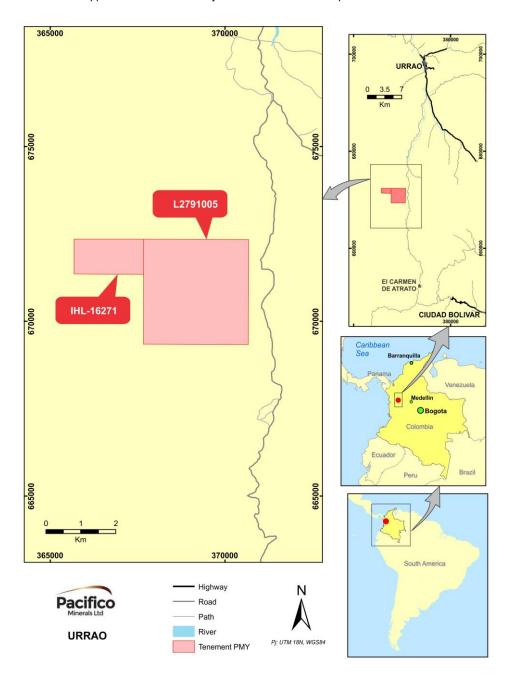


Figure 7: Urrao Project location map



OPERATIONS REPORT – AUSTRALIA

BORROLOOLA WEST PROJECT, NORTHERN TERRITORY – COPPER/ZINC/LEAD/SILVER/MANGANESE (PACIFICO 51%)

Pacifico has earned the right to a 51% interest in the Borroloola West Project from Sandfire Resources NL ("Sandfire") under a farm-in agreement, through staged exploration expenditures. The Borroloola West Project consists of 12 exploration licences and 1 mining licence (1,817 km2), and lies west and northwest of the world class McArthur River zinc-lead mine and Rox Resources' recently announced resource at the world class Teena zinc-lead deposit in the Northern Territory. The project area is underlain by the Proterozoic age McArthur Basin, the northern extension of the Mt Isa Basin and host to several world-class sediment hosted massive sulphide ("SHMS") deposits including the major zinc/lead/silver and copper deposit at Mt Isa and the zinc/lead/silver deposit currently being mined at the McArthur River (HYC) mine just 25km east of the project tenements. The project area also lies 200km SW of the world-class Groote Eylandt manganese mine. The exploration conducted by Pacifico on the Borroloola West Project has further enhanced the region's prospectivity for sediment-hosted copper, SHMS base metal mineralisation (zinc, lead and silver), and Groote Eylandt style manganese deposits, with several prospects now defined and ready for drill testing.

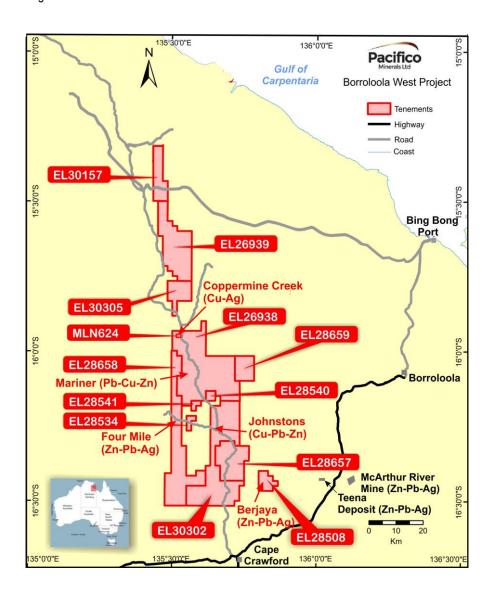


Figure 8: Borroloola West Project location map



During September 2015 Pacifico announced that it has completed expenditure of \$1.5 million at the Borroloola West Project, thereby earning the right to acquire a 51% interest from Sandfire. The Company has made an election and provided notice to Sandfire to maintain its 51% interest in the Project and form an unincorporated joint venture. This will see the Company holding its 51% interest and Sandfire holding a 49% interest.

As a result of both company's continuing positive view on the prospectivity of the project, Sandfire has agreed to contribute its 49% share of all exploration costs towards the 2016 program which will include reverse circulation ("RC") drilling of established targets at the Four Mile, Mariner, Berjaya, Coppermine Creek and Johnstons prospects.

The Borroloola West Project consists of 12 exploration licences (1,817 km²), and lies west and northwest of the world class McArthur River zinc-lead mine (figure 1) and Rox Resources' recently announced resource at the world class Teena zinc-lead deposit. Exploration by Pacifico continues to confirm the potential of the Borroloola West Project tenements for the discovery of major base metal deposits.

- At Four Mile (Zn, Pb, Ag) geological mapping has extended the mapped Barney Creek Formation carbonaceous and pyritic siltstone. The presence of high lead geochemistry (up to 0.26 %Pb laboratory analysis) with associated zinc and arsenic anomalism, along over 5km of strike, and observations of pyrite and dolomite nodules, are positive indicators for the presence of relatively shallow and gently dipping, stratiform zinc (lead silver) mineralisation of the McArthur River style, which can be tested for by RC drilling.
- At Mariner (Zn, Pb, Cu) previous exploration by Mount Isa Mines Ltd obtained a best drill intersection in RDH-1 of 16m at 7.9% Pb, in oxidised cerussite rich material, at the top of the Tooganinie Formation. RC drilling is planned to test for associated zinc mineralisation.
- RC drilling is also planned to test targets developed on the Berjaya (Zn, Pb), Coppermine Creek (Cu, Ag), and Johnstons (Zn, Cu, Pb) Prospects.

Coppermine Creek (copper)

Coppermine Creek is situated 100km north-west of the McArthur River zinc-lead-silver mine. The mineralised Gordons Fault is seen as outcropping gossans with malachite staining over a strike length of at least 900m. Reverse circulation ("RC") and diamond drilling had previously only been undertaken at the eastern extremity and produced results including 30m @ 1.1% Cu in RC hole GPR07 and 34m @ 0.5% Cu in RC hole GPR09¹. The 700m strike extent of the mineralised fault to the west was completely untested by drilling. During the year, Pacifico announced very encouraging visual results from its 3 hole drilling program at the Coppermine Creek Prospect (see ASX announcement 13 July 2015 for further details). Drill core demonstrated that the Gordons Fault zone contains broad zones of brecciation and dolomite-silica alteration of siltstones with both disseminated chalcopyrite and bands of semi-massive chalcopyrite. Stratabound disseminated chalcopyrite away from the fault was also recognised, associated with a dolomitised ex-evaporite unit.

During the year Pacifico announced assay and interpretation results for the 3 hole drilling program (see ASX announcement 6 August 2015 for further details). Results confirmed that drilling intersected extensive zones of intense fracturing containing disseminations and lenses of semi-massive chalcopyrite. All three drill holes intersected copper mineralisation and confirmed the strike continuity of the east-west trending Gordons Fault.

During the year, diamond drilling commenced at Coppermine Creek. However, the Company announced that drilling was halted (9 November 2015). Diamond drilling of drill hole CCD04, positioned to intersect an airborne electromagnetic ("AEM") conductivity high, ceased due to total mechanical failure of the drill rig at a depth of 464m. The hole was planned to reach a depth of 600m, to intersect the highest conductivity of the AEM anomaly, which was considered to be possibly caused by a significant body of copper mineralisation.

The hole up to 464m intersected some zones of minor copper mineralisation and terminated in silicified Lower Mallapunyah Formation sediments, which contain dolomite and dolomitic siltstone horizons that may be conducive hosts for copper mineralisation. Between 382m and 400m downhole depth a carbonaceous siltstone with disseminated pyrite was intersected which was considered could be the cause of the AEM anomaly. A down-hole electromagnetic ("DHEM") was undertaken on CCD04 with a 400m surface loop capable of detecting conductive zones surrounding the drill hole. Results from the DHEM survey confirmed the validity of geological interpretation, but indicated the apparent bullseye was likely caused by near surface effects.

Bing Bong (copper-gold)

During the period Pacifico also completed a two-hole drill program at the Bing Bong prospect. Two diamond holes were drilled to 400m and 300m respectively, with 100m RC (reverse circulation) pre-collars. A thick sediment package belonging to the Roper Group was intersected with no significant mineralisation. Any intrusive present, as previously interpreted, may be considerably deeper. The core has been delivered to the NTGS as part of co-funding conditions where the NT Government will refund 50% of the direct drilling costs.

Four Mile (zinc-lead-silver)

At Four Mile geological mapping conducted during the period identified poorly outcropping Barney Creek Formation (host to the mineralisation at the McArthur River zinc-lead-silver mine) with a possible strike length of over 14km. Selected rock chips of outcrop are consistently high in lead within the Barney Creek Formation package of sediments. Small pods of gossan in the Barney Creek Formation sediments contain up 0.26% Pb (A.L.S. laboratory analysis), which is a highly positive indication in this very weathered terrane for significant zinc – lead mineralisation. A versatile time domain electromagnetics ("VTEM") survey was conducted previously by Pacifico over part of the area. There are clear targets to test the Barney Creek Formation for relatively shallow zinc – lead mineralisation, with RC and diamond drilling.

Beriava (zinc-lead-silver)

The Berjaya tenement lies about 30km west of the McArthur River Mine, Australia's largest zinc-lead-silver producer, and one of the largest zinc-lead-silver deposits in the world, with a total deposit size of 227Mt of 13.4% Zn + Pb³. Also Rox Resources Ltd's recently discovered Teena Deposit (exploration target of 60 - 80Mt of 8 - 12% Zn + Pb⁴) lies about 18km west of Pacifico's Berjaya tenement. The Berjaya tenement contains the Barney Creek Formation package, and major growth faults, key geological components at both the McArthur River mine and the Teena deposit.

Future exploration will likely include drill testing for zinc-lead-silver mineralisation, targeting the base metal prospective Barney Creek Formation close to major growth faults.

MOUNT JUKES PROJECT, TASMANIA - GOLD/BASE METALS (PACIFICO 16%, CORONA MINERALS LTD 84%)

The Mt Jukes Project is adjacent to the Vedanta owned Mt Lyell copper/gold project in Tasmania. Corona Minerals Ltd ("Corona") is the operator and manager of this project. Further details can be found on Corona's website www.coronaminerals.com.

SPRINGFIELD PROJECT, NEW SOUTH WALES - GOLD (PACIFICO 20%, STONEWALL RESOURCES LTD 80%)

During the quarter Pacifico was advised by the joint venture partner and operator, Stonewall Resources Ltd ("Stonewall") it had relinquished the Springfield tenement. Pacifico has no interest in pursuing the area.

The Group began the 2016 financial year with a cash reserve of \$2,765,307. During the year total exploration expenditure incurred by the Group amounted to \$919,913 (2015: \$1,902,576). RISK MANAGEMENT

A. Principles used to determine the nature and amount of remuneration (audited)

Remuneration Policy

The remuneration policy of the Company has been designed to align director and executive objectives with shareholder and business objectives by providing a fixed remuneration component and offering specific long-term incentives based on key performance areas affecting the Group's financial results. The Board believes the remuneration policy to be appropriate and effective in its ability to attract and retain the best executives and directors to run and manage the Group.

The Board's policy for determining the nature and amount of remuneration for Board members and senior executives of the Group is as follows:

- The remuneration policy, setting the terms and conditions for the executive directors and other senior executives, was developed by the Board. All executives receive a base salary (which is based on factors such as length of service and experience) and superannuation. The Board reviews executive packages annually by reference to the Group's performance, executive performance and comparable information from industry sectors and other listed companies in similar industries.
- The Board may exercise discretion in relation to approving incentives, bonuses and options. The policy is designed to attract and retain the highest calibre of executives and reward them for performance that results in long-term growth in shareholder wealth.
- Executives are also entitled to participate in the employee share and option arrangements.
- The executive directors receive superannuation guarantee contributions required by the government, amounting to 9.5% during the year and do not receive any other retirement benefits.
- All remuneration paid to directors and executives is valued at the cost to the Group and expensed. Options are valued using the Black-Scholes methodology.

The Board's policy is to remunerate non-executive directors at market rates for comparable companies for time, commitment and responsibilities. The Board determines payments to the non-executive directors and reviews their remuneration annually, based on market practice, duties and accountability. Independent external advice is sought when required. The maximum aggregate amount of fees that can be paid to non-executive directors is subject to approval by shareholders at the Annual General Meeting (currently \$200,000). Fees for non-executive directors are not linked to the performance of the Group. However, to align directors' interests with shareholder interests, the directors are encouraged to hold shares in the Company.

Performance based remuneration

The Group currently has no performance based remuneration component built into director and executive remuneration packages.

Group performance, shareholder wealth and directors' and executives' remuneration

The remuneration policy has been tailored to increase the direct positive relationship between shareholders' investment objectives and directors' and executives' performance. Currently, this is facilitated through the issue of options to the majority of directors and executives to encourage the alignment of personal and shareholder interests. The Board believes this policy will be effective in increasing shareholder wealth. At commencement of mine production, performance based bonuses based on key performance indicators are expected to be introduced.

C. Service agreements (audited)

The service agreements of the KMP of the Company during the year are set out below:

(a) Executive Services Agreement with Mr Simon Noon

The material terms of this contract are:

THE BOARD OF DIRECTORS

The constitution of Pacifico Minerals Limited (the "Company") provides that the number of directors shall not be less than three and not more than nine. There is no requirement for any shareholding qualification.

As and if the Company's activities increase in size, nature and scope the size of the Board of Directors of the Company ("Board" or "Directors") will be reviewed periodically, and as circumstances demand. The optimum number of directors required to supervise adequately the Company's constitution will be determined within the limitations imposed by the constitution.

The membership of the Board, its activities and composition, is subject to periodic review. The criteria for determining the identification and appointment of a suitable candidate for the Board shall include quality of the individual, background of experience and achievement, compatibility with other Board members, credibility within the Company's scope of activities, intellectual ability to contribute to Board's duties and physical ability to undertake Board's duties and responsibilities.

The Board comprises individuals with the following skills that are deemed to be relevant to the organisations activities (ranked 1 to 5 with 5 being the highest ranking):

Subject to the requirements of the Corporations Act 2001, the Board does not subscribe to the principle of retirement age and there is no maximum period of service as a director. A managing director may be appointed for any period and on any terms the directors think fit and, subject to the terms of any agreement entered into, the directors may revoke any appointment.

The Board considers that the Company is not currently of a size, nor are its affairs of such complexity to justify the formation of separate or special committees at this time. The Board as a whole is able to address the governance aspects of the full scope of the Company's activities and to ensure that it adheres to appropriate ethical standards.

Directors consider, on an ongoing basis, how management information is presented to them and whether such information is sufficient to enable them to discharge their duties as directors of the Company. Such information must be sufficient to enable the directors to determine appropriate operating and financial strategies from time to time in light of changing circumstances and economic conditions. The directors recognise that mineral exploration is an inherently risky business and that operational strategies adopted should, notwithstanding, be directed towards improving or maintaining the net worth of the Group.

- 7.2 The board or a committee of the board should:
 - (a) review the entity's risk management framework at least annually to satisfy itself that it continues to be sound; and
 - (b) disclose, in relation to each reporting period, whether such a review has taken place.
- 7.3 A listed entity should disclose:
 - (a) if it has an internal audit function, how the function is structured and what role it performs; or

The remuneration of executive and non-executive Directors is reviewed by the Board with the exclusion of the director concerned. The remuneration of management and employees is reviewed by the Board and approved by the chairman.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The principal accounting policies adopted in the preparation of the financial report are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated. The financial report includes the financial statements for Pacifico Minerals Limited ("Parent Entity" or "Company") and its subsidiaries (the "Group") for the year ended 30 June 2016. The financial report of the Group for the year ended 30 June 2016 was authorised for issue in accordance with a resolution of the Board of Directors of Pacifico Minerals Limited ("Board" or "Directors") on 2 September 2016. Pacifico Minerals Limited is a company incorporated in Australia whose shares are publicly traded on the Australian Securities Exchange. The nature of the operations and principal activities of the Group are the exploration of mineral tenements in Australia and Colombia.

(a) Basis of preparation

This general purpose financial report has been prepared in accordance with Australian Accounting Standards, other authoritative pronouncements of the Australian Accounting Standards Board, Australian Interpretations and the Corporations Act 2001.

(i) Compliance with IFRS

Australian Accounting Standards include Australian equivalents to International Financial Reporting Standards (AIFRS). Compliance with AIFRS ensures that the financial statements and notes of Pacifico Minerals Limited comply with International Financial Reporting Standards (IFRS).

(ii) Historical cost convention

These financial statements have been prepared under the historical cost convention, as modified by the revaluation of available-forsale financial assets, financial assets and liabilities at fair value through profit or loss, certain classes of property, plant and equipment.

(iii) Going concern basis

The financial report has been prepared on the going concern basis, which contemplates continuity of normal business activities and realisation of assets and settlement of liabilities in the ordinary course of business. The going concern of the Group is dependent upon it maintaining sufficient funds for its operations and commitments. The Directors continue to monitor the ongoing funding requirements of the Group. The Directors are confident that sufficient funding can be secured if required to enable the Group to continue as a going concern and as such are of the opinion that the financial report has been appropriately prepared on a going concern basis.

(b) Principles of Consolidation

(i) Subsidiaries

Subsidiaries are all entities over which the Group has the power to govern the financial and operating policies, generally accompanying a shareholding of more than one half of the voting rights. The existence and effect of potential voting rights that are currently exercisable or convertible are considered when assessing whether the Group controls another entity. Subsidiaries are fully consolidated from the date on which control is transferred to the Group. They are de-consolidated from the date that control ceases. The acquisition method of accounting is used to account for business combinations by the Group (refer to note 1(d)). Intercompany transactions, balances and unrealised gains on transactions between Group companies are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of the impairment of the asset transferred. Accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the Group.

(ii) Investment in associates and joint ventures

Associates are all entities over which the Group has significant influence but not control or joint control. This is generally the case where the Group has significant voting rights. Investments in associates are accounted for using the equity method of accounting, after initially being recognised at cost. A joint venture is an arrangement in which the Group has joint control, whereby the Group has rights to the net assets of the arrangement, rather than rights to its assets and obligations for its liabilities. Joint control is defined as the contractually agreed sharing of control of an arrangement, which exists only when decisions about the relevant activities require the unanimous consent of the parties sharing control. Interests in joint ventures are accounted for using the equity method.

Under the equity method of accounting, the investments are initially recognised at cost and adjusted thereafter to recognise the Group's share of the post-acquisition profits or losses of the investee in profit or loss, and the Group's share of movements in other comprehensive income of the investee in other comprehensive income. Goodwill relating to the joint venture is included in the carrying amount of the investment and is neither amortised nor individually tested for impairment. Dividends received or receivable from associates and joint ventures are recognised as a reduction in the carrying amount of the investment. The financial statements of the associate or joint venture are prepared for the same reporting period as the Group. When necessary, adjustments are made to bring the accounting policies in line with those of the Group.

After application of the equity method, the Group determines whether it is necessary to recognise an impairment loss on its investment in its associate or joint venture. An impairment loss is measured by comparing the recoverable amount of the investment with its carrying amount. An impairment loss is recognised in the Consolidated Statement of Profit or Loss and Other Comprehensive Income, and is reversed if there has been a favourable change in the estimates used to determine the recoverable amount. Upon loss of significant influence over the associate or joint control over the joint venture, the Group measures and recognises any retained investment at its fair value. Any difference between the carrying amount of the associate or joint venture upon loss of significant influence or joint control and the fair value of the retained investment and proceeds from disposal is recognised in profit or loss.

(iii) Investment in joint operations

A joint operation is an arrangement in which the parties with joint control have rights to the assets and obligations for the liabilities relating to that arrangement. In respect of its interest in a joint operation, a joint operator must recognise all of its assets, liabilities, revenues and expenses, including its relative share of jointly controlled assets, liabilities, revenue and expenses.

(c) Foreign Currency Translation

(i) Functional and presentation currency

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates ("the functional currency"). The consolidated financial statements are presented in Australian dollars, which is Pacifico's functional and presentation currency. The functional currency of the companies subsidiaries in Colombia is the Colombian Peso.

(ii) Transactions and balances

Foreign currency transactions are translated into the functional currency using the exchange rates prevailing at the dates of the transactions. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation at year end exchange rates of monetary assets and liabilities denominated in foreign currencies are recognised in profit or loss, except when they are deferred in equity as qualifying cash flow hedges and qualifying net investment hedges or are attributable to part of the net investment in a foreign operation. Foreign exchange gains and losses that relate to borrowings are presented in the income statement, within finance costs. All other foreign exchange gains and losses are presented in the income statement on a net basis within other income or other expenses.

Non-monetary items that are measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was determined. Translation differences on assets and liabilities carried at fair value are reported as part of the fair value gain or loss. For example, translation differences on non-monetary assets and liabilities such as equities held at fair value through profit or loss are recognised in profit or loss as part of the fair value gain or loss and translation differences on non-monetary assets such as equities classified as available-for-sale financial assets are recognised in other comprehensive income.

(iii) Group companies

The results and financial position of foreign operations (none of which has the currency of a hyperinflationary economy) that have a functional currency different from the presentation currency are translated into the presentation currency as follows:

- assets and liabilities for each balance sheet presented are translated at the closing rate at the date of that balance sheet
- income and expenses for each income statement and statement of comprehensive income are translated at average exchange rates (unless this is not a reasonable approximation of the cumulative effect of the rates prevailing on the transaction dates, in which case income and expenses are translated at the dates of the transactions), and
- all resulting exchange differences are recognised in other comprehensive income.

On consolidation, exchange differences arising from the translation of any net investment in foreign entities, and of borrowings and other financial instruments designated as hedges of such investments, are recognised in other comprehensive income. When a foreign operation is sold or any borrowings forming part of the net investment are repaid, the associated exchange differences are reclassified to profit or loss, as part of the gain or loss on sale. Goodwill and fair value adjustments arising on the acquisition of a foreign operation are treated as assets and liabilities of the foreign operation and translated at the closing rate.

(d) Business Combinations

The acquisition method of accounting is used to account for all business combinations, regardless of whether equity instruments or other assets are acquired. The consideration transferred for the acquisition of a subsidiary comprises the fair values of the assets transferred, the liabilities incurred and the equity interests issued by the Group. The consideration transferred also includes the fair value of any asset or liability resulting from a contingent consideration arrangement and the fair value of any pre-existing equity interest in the subsidiary. Acquisition-related costs are expensed as incurred. Identifiable assets acquired and liabilities and contingent liabilities assumed in a business combination are, with limited exceptions, measured initially at their fair values at the acquisition date. On an acquisition-by-acquisition basis, the Group recognises any non-controlling interest in the acquiree either at fair value or at the non-controlling interest's proportionate share of the acquiree's net identifiable assets.

The excess of the consideration transferred and the amount of any non-controlling interest in the acquiree over the fair value of the net identifiable assets acquired is recorded as goodwill. If those amounts are less than the fair value of the net identifiable assets of the subsidiary acquired and the measurement of all amounts has been reviewed, the difference is recognised directly in profit or loss as a bargain purchase. Where settlement of any part of cash consideration is deferred, the amounts payable in the future are discounted to their present value as at the date of exchange. The discount rate used is the entity's incremental borrowing rate, being the rate at which a similar borrowing could be obtained from an independent financier under comparable terms and conditions. Contingent consideration is classified either as equity or a financial liability. Amounts classified as a financial liability are subsequently remeasured to fair value with changes in fair value recognised in profit or loss.

(e) Segment reporting

Operating segments are classified, identified and segment information disclosed on the basis of internal reports that are provided to or received by the Group's chief operating decision maker which, for the Group is its Board. The Group operates in Australia and Colombia and predominately in the field of mineral exploration.

(f) Revenue recognition

Interest revenue is recognised on a time proportionate basis that takes into account the effective yield on the financial assets.

(g) Income tax

The income tax expense or revenue for the year is the tax payable on the current period's taxable income based on the national income tax rate for each jurisdiction adjusted by changes in deferred tax assets and liabilities attributable to temporary differences and to unused tax losses. Deferred income tax is provided in full, using the liability method, on temporary differences arising between the tax bases of assets and liabilities and their carrying amounts in the financial statements. However, the deferred income tax is not accounted for if it arises from initial recognition of an asset or liability in a transaction other than a business combination that at the time of the transaction affects neither accounting nor taxable profit nor loss. Deferred income tax is determined using tax rates (and laws) that have been enacted or substantially enacted by the balance sheet date and are expected to apply when the related deferred income tax asset is realised or the deferred income tax liability is settled.

Deferred tax assets are recognised for deductible temporary differences and unused tax losses only if it is probable that future taxable amounts will be available to utilise those temporary differences and losses. Deferred tax assets and liabilities are offset when there is a legally enforceable right to offset current tax assets and liabilities and when the deferred tax balances relate to the same taxation authority. Current tax assets and tax liabilities are offset where the entity has a legally enforceable right to offset and intends either to settle on a net basis, or to realise the asset and settle the liability simultaneously. Current and deferred tax balances attributable to amounts recognised directly in equity are also recognised directly in equity.

(h) Leases

Leases of property, plant and equipment where the Group, as lessee, has substantially borne all the risks and rewards of ownership are classified as finance leases. Finance leases are capitalised at the lease's inception at the fair value of the leased property or, if lower, the present value of the minimum lease payments. The corresponding rental obligations, net of finance charges, are included in other short-term and long-term payables. Each lease payment is allocated between the liability and finance cost. The finance cost is charged to the income statement over the lease period so as to produce a constant periodic rate of interest on the remaining balance of the liability for each period. The property, plant and equipment acquired under finance leases is depreciated over the shorter of the asset's useful life and the lease term. Leases where a significant portion of the risks and rewards of ownership are not transferred to the Group as lessee are classified as operating leases. Payments made under operating leases (net of any incentives received from the lessor) are charged to the income statement on a straight-line basis over the period of the lease.

(i) Impairment of assets

Goodwill and intangible assets that have an indefinite useful life are not subject to amortisation and are tested annually for an impairment or more frequently if events or changes in circumstances indicate that they might be impaired. Other assets are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less costs to sell and value in use. For the purposes of assessing impairment, assets are grouped at the lowest levels for which there are separately identifiable cash inflows which are largely independent of the cash inflows from other assets or groups of assets (cash-generating units). Non-financial assets other than goodwill that suffered an impairment are reviewed for possible reversal of the impairment at each reporting date.

(j) Cash and cash equivalents

For cash flow statement presentation purposes, cash and cash equivalents includes cash on hand, deposits held at call with financial institutions, other short-term highly liquid investments with original maturities of three months or less that are readily convertible to known amounts of cash and which are subject to insignificant risk of changes in value, and bank overdrafts. Bank overdrafts are reported within short-term borrowings in current liabilities in the statement of financial position.

(k) Trade and other receivables

Receivables are recognised and carried at original invoice amount less a provision for any uncollectible debts. An estimate for doubtful debts is made when collection of the full amount is no longer probable. Bad debts are written-off as incurred.

(I) Investments and other financial assets

(i) Classification

The Group classifies its investments in the following categories: financial assets at fair value through profit or loss, loans and receivables, held-to-maturity investments and available-for-sale financial assets. The classification depends on the purpose for which the investments were acquired. Management determines the classification of its investments at initial recognition and, in the case of assets classified as held-to-maturity, re-evaluates this designation at each reporting date. Financial assets at fair value through profit or loss are financial assets held for trading. A financial asset is classified in this category if acquired principally for the purpose of selling in the short term. Derivatives are classified as held for trading unless they are designated as hedges. Assets in this category are classified as current assets. Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. They are included in current assets, except for those with maturities greater than 12 months after the balance sheet date which are classified as non-current assets. Loans and receivables are included in trade and other receivables in the balance sheet.

Held-to-maturity investments are non-derivative financial assets with fixed or determinable payments and fixed maturities that the Group's management has the positive intention and ability to hold to maturity. If the Group were to sell other than an insignificant amount of held-to-maturity financial assets, the whole category would be tainted and reclassified as available-for-sale. Held-to-maturity financial assets are included in non-current assets, except for those with maturities less than 12 months from the reporting date, which are classified as current assets. Available-for-sale financial assets, comprising principally marketable equity securities, are non-derivatives that are either designated in this category or not classified in any of the other categories. They are included in non-current assets unless management intends to dispose of the investment within 12 months of the balance sheet date.

(ii) Recognition and derecognition

Regular purchases and sales of financial assets are recognised on trade-date – the date on which the Group commits to purchase or sell the asset. Investments are initially recognised at fair value plus transaction costs for all financial assets not carried at fair value through profit or loss. Financial assets carried at fair value through profit or loss are initially recognised at fair value and transaction costs are expensed to the income statement. Financial assets are derecognised when the rights to receive cash flows from the financial assets have expired or have been transferred and the Group has transferred substantially all the risks and rewards of ownership. When securities classified as available-for-sale are sold, the accumulated fair value adjustments recognised in equity are included in the income statement as gains and losses from investment securities.

(iii) Subsequent measurement

Loans and receivables and held-to-maturity investments are carried at amortised cost using the effective interest method. Available-for-sale financial assets and financial assets at fair value through profit or loss are subsequently carried at fair value. Gains or losses arising from changes in the fair value of the 'financial assets at fair value through profit or loss' category are presented in the income statement within other income or other expenses in the period in which they arise. Dividend income from financial assets at fair value through profit or loss is recognised in the income statement as part of revenue from continuing operations when the Group's right to receive payments is established. Changes in the fair value of monetary securities denominated in a foreign currency and classified as available-for-sale are analysed between translation differences resulting from changes in amortised cost of the security and other changes in the carrying amount of the security. The translation differences related to changes in the amortised cost are recognised in profit or loss, and other changes in carrying amount are recognised in equity. Changes in the fair value of other monetary and non-monetary securities classified as available-for-sale are recognised in equity.

(iv) Fair value

The fair values of quoted investments are based on last trade prices. If the market for a financial asset is not active (and for unlisted securities), the Group establishes fair value by using valuation techniques. These include the use of recent arm's length transactions, reference to other instruments that are substantially the same, discounted cash flow analysis, and option pricing models making maximum use of market inputs and relying as little as possible on entity-specific inputs.

(v) Impairment

The Group assesses at each balance date whether there is objective evidence that a financial asset or Group of financial assets is impaired. In the case of equity securities classified as available-for-sale, a significant or prolonged decline in the fair value of a security below its cost is considered as an indicator that the securities are impaired. If any such evidence exists for available-for-sale financial assets, the cumulative loss – measured as the difference between the acquisition cost and the current fair value, less any impairment loss on that financial asset previously recognised in profit or loss – is removed from equity and recognised in the income statement. Impairment losses recognised in the income statement on equity instruments classified as available-for-sale are not reversed through the income statement.

(vi) Fair value estimation

The fair value of financial assets and financial liabilities must be estimated for recognition and measurement, or for disclosure purposes. The fair value of financial instruments traded in active markets (such as publicly traded derivatives, and trading and available-for-sale securities) is based on quoted market prices at the balance sheet date. The quoted market price used for financial assets held by the Group is the last trade price. The carrying value less impairment provision of trade receivables and payables are assumed to approximate their fair values due to their short-term nature.

(m) Plant and equipment

All plant and equipment is stated at historical cost less depreciation. Historical cost includes expenditure that is directly attributable to the acquisition of the items. Depreciation of plant and equipment is calculated using the straight line method to allocate their cost, net of their residual values, over their estimated useful lives. The rates vary between 10% and 100% per annum. The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at each balance sheet date. An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount (note 1(i)).

Gains and losses on disposals are determined by comparing proceeds with carrying amount. These are included in the income statement. When revalued assets are sold, it is Group policy to transfer the amounts included in other reserves in respect of those assets to retained earnings.

(n) Exploration and evaluation costs

Exploration and evaluation costs are written off in the year they are incurred apart from acquisition costs which are carried forward where right of tenure of the area of interest is current, and they are expected to be recouped through sale or successful development and exploitation of the area of interest, or, where exploration and evaluation activities in the area of interest have not reached a stage that permits reasonable assessment of the existence of economically recoverable reserves. Where an area of interest is abandoned, or the Directors decide that it is not commercial, any accumulated acquisition costs in respect of that area are written off in the financial period the decision is made. Each area of interest is also reviewed at the end of each accounting period and accumulated costs written off to the extent that they will not be recoverable in the future.

(o) Trade and other payables

These amounts represent liabilities for goods and services provided to the Group prior to the end of the financial year which are unpaid. The amounts are unsecured and are paid on normal commercial terms.

(p) Employee benefits

(i) Wages and salaries, annual leave and other employee benefits

Provision is made for employee benefits accumulated as a result of employees rendering services up to the reporting date. These benefits include wages and salaries, annual leave, and long service leave. Liabilities arising in respect of wages and salaries, annual leave and any other employee benefits expected to be settled within twelve months of the reporting date are measured at their nominal amounts based on remuneration rates which are expected to be paid when the liability is settled. All other employee benefit liabilities are measured at the present value of the estimated future cash outflow to be made in respect of services provided by employees up to the reporting date. In determining the present value of future cash outflows, the market yield as at the reporting date on national government bonds, which have terms to maturity approximating the terms of the related liability, are used.

(ii) Share-based payments

The Group provides benefits to employees (including Directors) and contractors of the Group in the form of share-based payment transactions, whereby employees and contractors render services in exchange for shares or rights over shares ('equity-settled transactions'). The cost of these equity-settled transactions with employees is measured by reference to the fair value at the date at which they are granted. The fair value is determined by an internal valuation using a Black-Scholes option pricing model. The cost of equity-settled transactions is recognised, together with a corresponding increase in equity, over the period in which the performance conditions are fulfilled, ending on the date on which the relevant employees become fully entitled to the award ('vesting date').

The cumulative expense recognised for equity-settled transactions at each reporting date until vesting date reflects:

- the extent to which the vesting period has expired; and
- the number of options that, in the opinion of the Directors of the Group, will ultimately vest.

This opinion is formed based on the best available information at balance date. No adjustment is made for the likelihood of market performance conditions being met as the effect of these conditions is included in the determination of fair value at grant date. No expense is recognised for awards that do not ultimately vest, except for awards where vesting is conditional upon a market condition. Where an equity-settled award is cancelled, it is treated as if it had vested on the date of cancellation, and any expense not yet recognised for the award is recognised immediately. However, if a new award is substituted for the cancelled award, and designated as a replacement award on the date that it is granted, the cancelled and new awards are treated as if they were a modification of the original award.

(q) Contributed equity

Ordinary shares are classified as equity. Incremental costs directly attributable to the issue of new shares or options are shown in equity as a deduction, net of tax, from the proceeds. Incremental costs directly attributable to the issue of new shares or options, for the acquisition of a business, are not included in the cost of the acquisition as part of the purchase consideration.

(r) Earnings per share

(i) Basic earnings per share

Basic earnings per share is calculated by dividing the profit attributable to equity holders of the Parent Entity, excluding any costs of servicing equity other than ordinary shares, by the weighted average number of ordinary shares outstanding during the financial year, adjusted for bonus elements in ordinary shares issued during the year.

(ii) Diluted earnings per share

Diluted earnings per share adjusts the figures used in the determination of basic earnings per share to take into account the after income tax effect of interest and other financing costs associated with dilutive potential ordinary shares and the weighted average number of shares assumed to have been issued for no consideration in relation to dilutive potential ordinary shares.

(s) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of associated GST, unless the GST incurred is not recoverable from the taxation authority. In this case it is recognised as part of the cost of acquisition of the asset or as part of the expense. Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the taxation authority is included with other receivables or payables in the balance sheet. Cash flows are presented on a gross basis. The GST components of cash flows arising from investing or financing activities which are recoverable from, or payable to the taxation authority, are presented as operating cash flow.

(t) Rounding of amounts

The Group is of a kind referred to ASIC Corporations Rounding in financial Directors' Reports instrument 2016/191, issued by the Australian Securities and Investments Commission, relating to the "rounding off" of amounts in the financial report. Amounts in the financial report have been rounded off in accordance with that Class Order to the nearest \$1.

(u) Significant accounting estimates and judgements

The carrying amount of certain assets and liabilities are often determined based on estimates and assumptions of future events. The key estimates and assumptions that have significant risk of causing a material adjustment to the carring amounts of certain assets and liabilities within the next annual reporting period are:

(i) Deferred taxation

The potential deferred tax asset arising from the tax losses and temporary differences have not been recognised as an asset because recovery of the tax losses is not yet considered probable.

(ii) Capitalised exploration costs

The application of the Group's accounting policy for exploration and evaluation expenditure requires judgement in determining whether it is likely that future economic benefits are likely, either from exploration or sale, or where activities have not reached a stage which permits reasonable assessment.

2. NEW STANDARDS AND INTERPRETATIONS ADOPTED AND NOT YET ADOPTED

(a) New standards and interpretations adopted in 2015/2016 financial year

The consolidated entity has adopted all of the new, revised or amending Accounting Standards and Interpretations issued by the Australian Accounting Standards Board ('AASB') that are mandatory for the current reporting period. The adoption of these Accounting Standards and Interpretations did not have any significant impact on the financial performance or position of the consolidated entity during the financial year. Any new, revised or amending Accounting Standards or Interpretations that are not yet mandatory have not been early adopted.

(b) New standards and interpretations not yet adopted

Australian Accounting Standards and Interpretations that have recently been issued or amended but are not yet mandatory, have not been early adopted by the consolidated entity for the annual reporting period ended 30 June 2016. The consolidated entity's assessment of the impact of these new or amended Accounting Standards and Interpretations, most relevant to the consolidated entity, are set out below.

AASB 9 Financial Institutions

This standard is applicable to annual reporting periods beginning on or after 1 January 2018. The standard replaces all previous versions of AASB 9 and completes the project to replace IAS 39 'Financial Instruments: Recognition and Measurement'. AASB 9 introduces new classification and measurement models for financial assets. A financial asset shall be measured at amortised cost, if it is held within a business model whose objective is to hold assets in order to collect contractual cash flows, which arise on specified dates and solely principal and interest. All other financial instrument assets are to be classified and measured at fair value through profit or loss unless the entity makes an irrevocable election on initial recognition to present gains and losses on equity instruments (that are not held-for-trading) in other comprehensive income ('OCI'). For financial liabilities, the standard requires the portion of the change in fair value that relates to the entity's own credit risk to be presented in OCI (unless it would create an accounting mismatch). New impairment requirements will use an 'expected credit loss' ('ECL') model to recognise an allowance. Impairment will be measured under a 12-month ECL method unless the credit risk on a financial instrument has increased significantly since initial recognition in which case the lifetime ECL method is adopted. The standard introduces additional new disclosures. The consolidated entity will adopt this standard from 1 July 2018 but the impact of its adoption is yet to be assessed by the consolidated entity.

AASB 15: Revenue from Contracts with Customers (applicable to annual reporting periods commencing on or after 1 January 2018).

When effective, this Standard will replace the current accounting requirements applicable to revenue with a single, principles based model. Except for a limited number of exceptions, including leases, the new revenue model in AASB 15 will apply to all contracts with customers as well as non monetary exchanges between entities in the same line of business to facilitate sales to customers and potential customers. The core principle of the Standard is that an entity will recognise revenue to depict the transfer of promised goods or services to customers in an amount that reflects the consideration to which the entity expects to be entitled in exchange for the goods or services. To achieve this objective, AASB 15 provides the following five step process:

- identify the contract(s) with a customer;
- identify the performance obligations in the contract(s);
- determine the transaction price;
- allocate the transaction price to the performance obligations in the contract(s); and
- recognise revenue when (or as) the performance obligations are satisfied.

This Standard will require retrospective restatement, as well as enhanced disclosures regarding revenue. The directors anticipate that the adoption of AASB 15 will not have a material impact on the Group's revenue recognition and disclosures.

AASB 16: Leases (applicable to annual reporting periods commencing on or after 1 January 2019).

AASB 16 removes the classification of leases as either operating leases or finance leases for the lessee effectively treating all leases as finance leases. Short term leases (less than 12 months) and leases of a low value are exempt from the lease accounting requirements. Lessor accounting remains similar to current practice. Although the directors anticipate that the adoption of AASB 16 may have an impact on the Group's financial statements, it is impracticable at this stage to provide a reasonable estimate of such impact.

3. FINANCIAL RISK MANAGEMENT

(a) Interest rate risk

The Group is exposed to movements in market interest rates on short-term deposits. The policy is to monitor the interest rate yield curve out to 120 days to ensure a balance is maintained between the liquidity of cash assets and the interest rate return. At 30 June 2016, if interest rates had changed by -/+ 100 basis points from the year-end rates with all other variables held constant, post-tax loss would have been \$13,340 lower/higher (2015 – change of 100 bps: \$26,231 lower/higher) as a result of lower interest income. The Group's exposure to interest rate risks and the effective interest rates of financial assets and financial liabilities, both recognised and unrecognised at the balance date, are as follows:
