Placement Completed Cleansing Notice & Appendix 2A

Further to the Appendix 3B released on 18 September 2020, Pacifco Minerals Limited ('**Pacifco**' or the '**Company**') advises that it has now issued 555,555,920 fully paid ordinary shares at an offer price of \$0.018 per share, (the "**Placement**"). The Placement was undertaken within the Company's existing placement capacities under ASX Listing Rules 7.1 and 7.1A.

The shares have been issued without disclosure under Part 6D.2 of the *Corporations Act 2001* (Cth) (the '**Act**'), in reliance on section 708A(5)(e) of the *Corporations Act*.

The Act restricts the on-sale of securities issued without disclosure, unless the sale is exempt under section 708 or 708A. By the Company giving this notice, sale of the securities noted above will fall within the exemption in section 708A(5)(e) of the Act.

As at the date of this notice, the Company has complied with:

- a) the provisions of Chapter 2M of the Act as they apply to the Company; and
- b) section 674 of the Act.
