GRES Selected as Preferred EPC Contractor for Expanded Sorby Hills Process Plant

Boab Metals Limited (ASX: **BML**) (“**Boab**” or “**Company**”) is pleased to announce that GR Engineering Services Limited (“**GRES**”, ASX:GNG) has been selected as the Preferred EPC Contractor to deliver an expanded Process Plant for the Sorby Hills Lead-Silver Project (“**Sorby Hills**”, the “**Project**”) located in the Kimberley Region of Western Australia.

HIGHLIGHTS

- **GRES selected as Preferred EPC Contractor** for the Process Plant at Sorby Hills.
- Scope of work includes a **process plant with a capacity of 2.25Mtpa**, representing a 50% increase over that considered in the Sorby Hills Pre-Feasibility Study (“PFS”).
- **Tendered Price** is commensurate with the proposed capacity expansion and will form the basis of capital cost estimates for the Definitive Feasibility Study (“DFS”).
- **Commercial Agreement and Contract Award to be finalised over the coming months** as Sorby Hills progresses toward a Final Investment Decision.
- **Parties to execute a Detailed Design and Procurement Agreement** to advance key workstreams ahead of finalising the full EPC contract.

The selection of GRES is the outcome of a highly competitive EPC tender process which saw strong submissions received from a range of leading engineering firms. The tendered price includes a scope of work covering the design, engineering, procurement, and construction of a process plant with a maximum capacity of 2.25Mtpa as well as associated non-process infrastructure.

The design scope represents a 50% increase in the maximum capacity of the process plant versus that considered in the Sorby Hills PFS.

Note that the value of 2.25Mtpa represents the maximum design feed capacity included in the tendered scope of work submitted by GRES. It should not be considered a Production Target nor as evidence of the project's economic viability, which remains subject to the results of the ongoing Definitive Feasibility Study due for completion in Q4 2022.

It is intended that the EPC contract will be executed between GRES and Sorby Management Pty Ltd, Manager of the Sorby Hills Joint Venture, following a Final Investment Decision on the Project. In the meantime, the parties will execute a Detailed Design and Procurement Agreement to advance key workstreams ahead of finalising the full EPC Contract.

The selection of GRES as the preferred EPC contractor is consistent with the Company's focus on project execution workstreams. The tendered prices are an outstanding result given the current inflationary economic environment.

The Company looks forward to working with GRES to deliver the Sorby Hills Project.

The Board of Directors have authorised this announcement for release to the market.
