## Section 708A(5)(e) Cleansing Notice

**Boab Metals Limited** (ASX:BML) (**Company**) advises that it has allotted and issued a total of 490,323 fully paid ordinary shares to the Managing Director on conversion of Performance Rights that were issued to him. The issue was triggered by the achievement of a milestone attaching to the Class "A" MD Performance Rights, being, the announcement to the ASX that all required permit approvals have been received to commence construction at the Sorby Hills Project.
